This policy (together with our website **terms of use**) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand how we will treat your personal data. By visiting www.rnvproperties.co.uk (our "site") you are accepting and consenting to the practices described in this policy.

For the purpose of the Data Protection Act 1998 (the "Act"), RNV Properties Ltd of 4 Newmans Row, Lincoln Inn, Lincoln Road, Cressex Business Park, High Wycombe, Buckinghamshire, HP12 3RE is the data controller.

Information we may collect from you:

We may collect and process the following data about you:

1) Information you give us: You may give us information about you by filling in forms on our sites or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you subscribe to our services, search our site, participate in social media functions on our site, enter a competition, promotion or survey and when you report a problem with our site. The information you give us may include your name, address, e-mail address, phone number and financial and credit card information.

2) Information we collect about you:

Each time you visit our site, we may automatically collect the following information:

2.1) Technical information, including the Internet Protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform; and information about your visit,



including the full Uniform Resource Locators (URL) clickstream to, through and from our sites (including date and time); information you viewed or searched for; page response times, download errors, length of visits to pages, page interaction information (such as scrolling, clicks, and mouseovers), and methods used to browse away from the page.

3) Information we receive from other sources: We may receive information about you if you use any of the other websites we operate or the other services we provide. We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment services, advertising networks, analytics providers, search information providers, credit reference agencies) and may receive information about you from them.

Cookies:

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our site and allows us to improve our site.

Uses made of the information:

We use information held about you in the following ways:

- 1) Information you give to us, we will use this information:
- **1.1)** to carry out our obligations arising from any contracts entered into between you and us and to provide you with the information, products and services that you request from us;
- **1.2)** to provide you with information about other services we offer that are similar to those on our site;
- **1.3)** to notify you about changes to our service;
- **1.4)** to ensure that content from our sites is presented in the most effective manner for you and for your computer; and



- 1.5) to provide you with information about services or market updates we feel may interest you. If you are an existing customer, we will only contact you by e-mail or SMS with information about services similar to those which we have already provided to you. If you have not previously purchased services from us we will only contact you by e-mail or SMS if you have consented to this e.g. by ticking a marketing preferences box on a form that we used to collect your information. You can contact us at any time
- **1.6)** to update your marketing preferences by clicking on the links that appear on the bottom of each of our marketing communications or by **Contacting Us.**

2) Information we collect about you, we will use this information:

- **1.1)** to administer our site and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- **1.2)** to improve our sites to ensure that content is presented in the most effective manner for you and for your computer;
- **1.3)** to monitor your compliance with contracts entered into between you and us;
- **1.4)** to allow you to participate in interactive features of our service;
- **1.5)** as part of our efforts to keep our sites safe and secure;
- **1.6)** to measure or understand the effectiveness of advertising we serve to you and others, and to deliver relevant advertising to you; and
- **1.7)** to make suggestions and recommendations to you about goods or services that may interest you.

Information we receive from other sources:

We may combine this information with information you give to us and information we collect about you. We may use this information and the combined information for the purposes set out above (depending on the types of information we receive).



Disclosure of your information:

You agree that we may share your personal information with:

- 1) Other member(s) of our corporate group from time to time (if any) selected third parties including:
- **1.1)** business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you;
- **1.2)** analytics and search engine providers that assist us in the improvement and optimisation of our sites; or
- **1.3)** credit reference agencies for the purpose of verifying your identity and/or assessing your credit score where this is a condition of us entering into a contract with you.
 - 2) We may disclose your personal information to third parties:
- **2.1)** in the event that we sell or let any business or assets, in which case we may disclose or transfer your personal data to the prospective seller or buyer or landlord or tenant of such business or assets;
- **2.2)** if RNV Properties Ltd or substantially all of its assets are acquired by a third party, in which case personal data we hold about our customers will be one of the transferred assets; or
- **2.3)** if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our website **Terms of Use** and other agreements; or to protect the rights, property, or safety of us, our customers, or others.

Where we store your personal data:

The data that we collect from you may be transferred to, and stored at a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our contractors. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.



Where we have given you (or where you have chosen) a password which enables you to access certain parts of our site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our sites; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access. Your rights:
